

## I. GENERAL

1. Promotional sales made under the name "Buy your set of tyres and get £25 Amazon voucher!" will henceforth be called "the Offer".
2. The Competition will be organised by Oponeo.co.uk Ltd. with its registered office at 46 Station Road, North Harrow, London, UK, HA2 7SE, (company number 08160779), a UK subsidiary of OPONEO.PL S.A., which has its registered office in Bydgoszcz, at Podleśna 17, ("the Organiser").
3. The Offer takes place on the Internet portal [www.oponeo.co.uk](http://www.oponeo.co.uk).
4. Duration of the Offer: from 25 November 2016 to 31 December 2016 or until 400 vouchers are granted.
5. 400 vouchers are shared between the United Kingdom and Spain.
6. The Offer applies to a purchase of a set of four or more car tyres (with the same goods index) of the Goodyear or Dunlop brand. Every such purchase will be rewarded with a shopping coupon.
